I. Personally-Identifiable Information and Non-Personally Identifiable Information. OBI BioAesthetics LLC (also referred to herein as OBI) may collect two different types of information, Personally Identifiable Information ("PII") and Non-Personally Identifiable Information ("Non-PII"). OBI reserves the right to disclose and use your PII if OBI believes it is necessary to: (a) respond to legal process, e.g., a subpoena; (b) respond to a law enforcement agency's request; (c) enforce the Terms; or (d) protect the rights, privacy, safety, property, or operations of OBI or third parties; Because Non-PII does not personally identify You, OBI reserves the right to use and disclose to third parties Non-PII for any purpose.

OBI maintains reasonable physical, administrative and technical safeguards to protect PII from loss, misuse, or unauthorized access, disclosure, alteration or destruction. OBI enforces its Privacy Policy via self-assessment.
